	Presentation to Board on Waiheke Ferry Service	Waiheke Local Board (Cath Handley & Robin Ticker)	Ms Handley and Ms Tucker spoke on behalf of the Waiheke Local Board. Ms Handley noted that the ferry service to Waiheke Island is characterised by a low competition environment. She noted that this having a negative effect on commuters including high prices and low service quality. Ms Handley noted that Island Direct is a new ferry operator that will be providing Waiheke Island ferry services, but noted her concern that it will be unable to compete with Fullers Group Limited due to its existing established marked position and factors such as the lack of advertising space on the downtow wharf. Ms Handley also noted her concern that the current wharf infrastructure at Matiatia Wharf is inadequate, which is causing substantial delays and commuter issues.  The Executive General Manager (EGM) Public Transport Services advised that AT has been working with and supporting Island Direct with the launch of its ferry services. She noted that Pier 2 on Waiheke is being rebuilt which will increase resilience on the network.  After in-depth discussion by the committee members, the following action was taken:  Action item: 2023Nov01: The EGM Public Transport Services to draft a memorandum addressing the concerns and questions raised by the Waiheke Local Board about the competitive environment on the Waiheke Island ferry route and how a 'level playing field' will be enabled.  Action response: AT has worked closely with ID to educate, inform and assist them entering the market, in an exceptionally short period. AT will continue to support ID with the installation of further wayfinding material and work through suitable locations to establish a physical presence at Matiatia. AT is actively monitoring the behaviour of other Operators in the DTFT and Matiatia basins and will address any concerns as necessary. AT are happy to attend any workshop that the Local Board would wish to call to discuss management of the operations. AT continues to actively respond to enquiries from interested parties about operating ferry services to Wai
